

## **The Tommy Bright Scholarship**

### **About the Scholarship**

This scholarship was established as a memorial to Tommy Bright who was a very active member of the Home Builders Association of the Bluegrass. Tommy was an advocate for involvement in government affairs and was elated when youth recognized their leadership potential.

The value of the scholarship is \$1,000.00.

### **Eligibility**

The Tommy Bright Scholarship is awarded to children of members of the Home Builders Association of Kentucky to assist those children in their pursuit of a post secondary degree. Scholarship recipients must:

- Be the child of a member in good standing of the Home Builders Association of Kentucky
- Be a graduating high school senior accepted by an accredited two year community college, four year college or university, a state vocational school or an enrolled undergraduate student.
- Be pursuing study in a housing related field, such as business management, architecture, government affairs or other related housing studies.

### **Selection**

The eleven trustees of the Tommy Bright Scholarship Fund will meet after the application filing date to determine the recipients. The selection committee will weigh all aspects of the application on an even level. Therefor care must be taken to fill out the entire form.
